2023 Priority Objectives

- Engage rabies-endemic countries and support development and implementation of National Strategic Plans
- Engage local authorities and communities to prioritise rabies elimination at the local level
- Engage with academic and industry partners to support country and regional implementation of rabies strategies
- Promote improved surveillance, data sharing and data reporting
- Support advocacy and resource mobilisation, including promoting access to human post exposure prophylaxis







- Improve awareness and uptake of available UAR Forum resources
 - Ongoing promotion in webinars, newsletters, regional and country meetings/workshops
- Better define activities, and ensure these are specific, measurable, attainable, relevant and timebound
 - Redefined objectives and timelines of ongoing activities, and developed Activity Proposal form for new activities
- Ensure activities are led by smaller productive groups of participants, while maintaining transparency and inclusiveness of the Forum



United Against Rabies Roadmap







- Linked to SARE, WOAH endorsement, and WHO validation of zero human deaths from dog-mediated rabies
- Included in the UAR M&E framework
- Continued mapping of tools/resources to link to the roadmap (including review of resources in Canine Rabies Blueprint)
- Promoted in various regional/country meetings and workshops
- Improved navigation of this on the website planned for 2024







- Providing evidence of benefits of dog identification in addition to mass dog vaccination
- UAR recommended revision of objectives and timeline of deliverables:
 - Dog collar specifications
 - Theory of change
 - Drafting protocol guidelines for pilot projects
- Anticipated to have outputs to share by end of 2023


Recommendations for field application and integration into dog rabies control programmes

- Scoping review finalised and publication anticipated in early 2024
- Limited evidence do you have examples of crosscutting or integrated approaches?

- Surveys completed looking at the main barriers to scaling up dog vaccination
- Document in development outlining solutions to identified barriers
- Launch of document in upcoming webinar on 5 December 2023
- Ongoing review every 6 months to update as new solutions identified
